- **b.** AP Review: AP 2.02.03 (5 minutes) Seth Shippee (See video @ 37:45): Return to Work: Reintegrating employees back into the workplace who have been out due to illness or injury without compromising their health. This should benefit both the institution and the employee (skill maintenance, earnings, and benefits).

  Transitional Duty: allows employee to return to work when they can use a significant portion of their skills & complete productive work (i.e. 70% of working capacity and is expected to make a full recovery).

Hilda and her department welcome faculty to visit her area (Downtown campus) and look at the Immigrant and Refugee resource center located upstairs @ DC. This division will be forming <a href="Employee Affinity Groups">Employee Affinity Groups</a> this fall, groups around identity, ability to connect to others in the college, also there will be opportunity to engage with the community to show that PCC wants to be a more inclusive environment. Hilda presented the results of the Equity & Inclusion survey, which was completed @ the end of last semester by then Director of ADR, John Howe (retired). The survey yielded ~569 responses and was open for just 2 weeks @ the end of May 2019. The initial question: Please check life experiences/identities that affect your experience @ the college was followed with further questions about each experience selected. Topics included:

Overall, the survey showed positive to very positive responses (5 choices ranged from Very negative –Very positive + not applicable). Hilda provided snippets of results. Both employees and students were invited to complete this survey. Key takeaways: conduct a comprehensive climate survey, explore opportunities to offer childcare resources, schedule classes & pathway completion options for working students, training for faculty.

# Faculty Qualifications and Draft AP Update (5 minutes) Kate Schmidt and Carol Christofferson (See Video @ 1:05:50)

a. 1AP 3.01.01 Draft: This is an existing AP following a quality review (completed every 3 years) in draft. Before it is taken through the formal 21 day review process, Kate wanted to bring it back to FS for comments and questions. Three changes were identified, albeit minor. First change: Academic credentials can be prioritized over master's degree (or higher) in any field + 18 credits. Second change: Min. Qualifications for each discipline will be reviewed by faculty every 3 years, not annually. Third change: The equivalency process will be streamlined. Please review the draft AP and provide comments.

### e. Early Alert

Early alert is a new system, now the scale has been opened to include gateway courses and developmental courses. To be proactive, Josie asked for feedback from senators who have used the system. Feedback included how flags communication during the middle and end of semester is sent to faculty can be a bit confusing, especially when trying to find the "new" information within the system faculty should review. Also, students see general feedback but have to hunt for individual faculty or advisor comments. Finally, the canned comments to students can be intimidating to some students, so an option to change the canned comment, or to add a faculty flag would be helpful. Recommend adding Dept. Chairs and/or Discipline Coordinators to the communications sent to faculty.

- 2. (See on video @ 2:22:07) Discrepancy between policy for staff instructors and faculty. Student Affairs has been reviewing the role of counselors of the past academic year, one change implemented from this review was the Student Wellness Assistance Program; Counselors were unsure how their services would be used with this new system. The provost created a counseling workgroup to benchmark ways that peer colleges utilize counseling responding to a new counseling model proposal shared with the Governing Board last semester (these proposals were not shared with the counselors before going to the board). This raised concerns with counselors that their voice was not being heard, even though they had written support from faculty senate, staff council and PCCEA. The results found that roughly 80% of community colleges reviewed have counseling faculty. The workgroup presented 3 models to address the charge and presented to Provost and Presidents. The outcome should be delivered around September 20, 2019.
