Recap: Counseling, faculty and student affairs leadership workgroup convened from May to August 2019 to review the roles of counseling and advising and determine what was best for Pima moving forward. Benchmarked IPEDs colleges with high graduation rates (assumed this was a characteristic of a premier college). Provided three models to ELT, unfortunately the recommendations were not selected. The decision was that counselors will lose their faculty status and be reclassified as staff. Of the 32 positions once held by counselors, the number has been decreased to 18. Of the 18, 10 will become staff counselor (current counselors will have to apply for these positions). The remaining will be offered Program Advisor roles.

Metrics have been implemented such as the QLess management system, real-time surveys and evaluations. The goal is to align services to diminish wait times, registration barriers and improve student relations.
